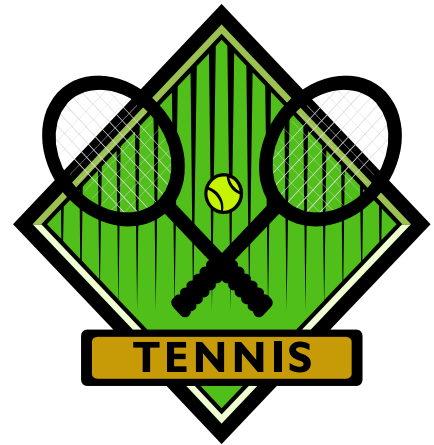
Camps, for Grades 1 and up, run Monday through
