APPLICATION FOR RIDGEWOOD PARKING PERMIT (RPP)

Permit Fee: \$1,300 per calendar year for Ridgewood residents for Train Station Lot, Prospect Lot and all lots (except Hudson Lot); \$1,300 per calendar year for Hudson Lot only with Ride Share Services; \$975 per calendar year for Ridgewood residents for Chestnut Lot, North Walnut Lot, Route 17 Park and Ride Lot, and Cottage Lot; \$1,950 per calendar year for non-residents for Cottage Lot; \$975 per calendar year for non-residents for Route 17 Park and Ride Lot. Fee prorated by month if purchased later in calendar year. The permit is a hangtag to be displayed from the vehicle rearview mirror when parked. In addition, residents must display the annual Ridgewood Resident Parking Sticker on passenger window behind the driver. **For flexibility, the permit can be used in up to 3 different approved cars but NOT at the same time. One permit allows residents to park in one parking space in specific parking lots. Non-residents may only park in the Cottage Place lot or Park and Ride lot on Route 17. If cars listed are for both residents and non-residents, then all cars listed will only be able to park in the non-resident lots and none of the cars will be issued Ridgewood Parking Stickers. Copy of driver's license and car registration required for each car listed on application.**

I understand the provisions of the Ridgewood Parking Permit, including the requirement to properly hang the permit placard from the rearview mirror when parked and to remove it before driving. I agree that the Village of Ridgewood, the Ridgewood Parking Utility, as well as its employees, shall not be held liable for any loss or damage to me, my guests, anyone else or to the above described vehicles, their equipment or their contents, occurring while said vehicles are parked in any of the parking lots, even if such personal injury or property damage is caused by negligence, actions, and/or inactions of the Ridgewood Parking Utility, its employees, or the Village of Ridgewood. I agree to hold the Ridgewood Parking Utility, its employees, and the Village of Ridgewood harmless for any such claims.

I further understand that the Village of Ridgewood does not directly or indirectly guarantee, by issuance of this permit, that there will be a parking space available in the designated off street lots (other than in the Hudson lot). In addition, I understand that there is no guarantee a parking space will always be available in premium Village parking lots, such as the Train Station and Prospect Street lots. The overflow lots are Chestnut Street, North Walnut Street and Cottage Place parking lots.

If the applicant is not the owner of the vehicle described above, he/she represents that this application is made with the knowledge and consent of the owner and that the owner is bound by the provisions thereof.
