

**RESIDENTIAL LOT AND BULK STANDARDS FOR SINGLE-FAMILY AND TWO-FAMILY ZONE DISTRICTS**

The tables below are a summary of the lot, bulk and intensity of use standards for single-family and two-family residential development in the single-family and two-family zone districts. THIS IS ONLY A SUMMARY; the text of Chapter 190 should be consulted for additional regulations not included in the tables, and for definitions, conditions and limiting provisions for these standards.
